DREAMS START FOR CITY OF DREAMS MANILA

Thousands witnessed spectacular launch of Manila's world-class entertainment-inspired leisure destination

MANILA – Tuesday, February 3, 2015: A spectacularly successful grand launch event at City of Dreams Manila saw over 30,000 visitors experience Manila's first-ever world-class entertainment-inspired leisure destination.
